### NOTICE INVITING TENDER

- Through item rate tenders are invited on behalf of the Director cum Principal ABVGIT Pragatinagar Distt. Shimla from the approved and eligible contractors of Jal Shakti Vibhag, BSNL (Civil Wing), CPWD, and State PWD (B&R) and other specialized Govt. agencies having requisite work experience are also eligible for tendering.
- The work is estimated to Cost - **Rs. 9,48,658 (Rupees Nine lakh Forty Eight Thousand Six Hundred Fifty Eight Only)** Tenders will be issued to eligible contractors provided they produce proof of their valid enlistment with the appropriate authority. Applicant shall submit valid registration document. The attested copies of certificates, testimonials and satisfactory completion certificates of works, from the department concerned, obtained from an officer not below the rank of Executive Engineer, in charge of work, shall be submitted while applying for participation in tender / issue of tender forms for the work. He / they shall submit attested copies of GST No, as per latest orders of G.O.I., on acceptance of tender along with Performance Guarantee. In the event of failure on the part of contractor (whose tender is accepted) to furnish the documents



- pertaining to GSTN along with Performance Guarantee within Stipulated Period, the earnest money will be forfeited and tender cancelled.
3. Criteria of eligibility for issue of tender documents for registered contractors of Public Works Organizations like CPWD, State PWD (B&R), Jal Shakti Vibhag and BSNL and other specialized Govt. agencies only.
  4. The applicant should have completed works as per details below during the last 7 (seven) years ending last day of the month previous to the one in which the tenders are invited.
    - a) Three similar completed works costing not less than 40% of the estimated cost Or
    - b) Two similar completed works costing not less than 50% of the estimated cost or
    - c) One similar completed works costing not less than 80% of the estimated cost
  5. The time allowed for carrying out the work will be 03 (Three) months from the 7th (Seventh) day after the date of issue of letter of award of work , or, from the first day of handing over of the site, whichever is later, in accordance with phasing, if any, indicated in the Tender Document.
  6. Payment to the contractors shall be made through e-payment system like ECS & EFT.
  7. The tenderer shall furnish a declaration to this effect (In case of downloaded tender) that no addition / deletion /correction have been made in the tender document submitted and it is identical to the tender document appearing on website. Every page of downloaded tender shall be signed by the tender with stamp (seal) of his firm / organization.
  8. All tendered rates shall be inclusive of all tax, levy or cess applicable on last stipulated date of receipt of tender including extension if an. No adjustment i.e. increases or decrease shall be made for any variation in the rate of GST, Building and Other Construction Workers Welfare Cess or any tax, levy or cess applicable on inputs.

#### **Terms & Conditions:**

1. The contractor should be a registered one having valid GSTIN number.
2. The rates should be quoted FOR Destination i.e. at Atal Bihari Vajpayee Govt. Institute of Engineering & Technology Pragatinagar Distt. Shimla (H.P).
3. The Technical bid and the financial bid should be sealed in separate covers and both the sealed covers containing "Technical bid" & "Financial bid" should be placed in a large sealed cover duly superscribed "Limited Tender construction work at office of the Director cum Principal Atal Bihari Vajpayee Govt. Institute of Engineering & Technology Pragatinagar Distt. Shimla (H.P) by 05.12.2025 up to 2pm.
4. The Limited Tender will be opened on 05.12.2025 at 3:00 pm by the committee constituted for the purpose. If it happens to be a holiday due to any unforeseen reason, the Limited Tender will be opened on the next working day at the same time and venue.
5. The Contractor is required to submit Tender documents along with self-signed declaration on the plain paper that he has gone through the whole Tender Document and understood the same. All Terms & condition as stipulated in the Tender Documents are acceptable to him.

6. Minimum guarantee period of 01 years is to be given compulsorily.
7. Rates for the items must be mentioned clearly showing inclusive all taxes (GST etc.)
8. Cutting and overwriting is strictly prohibited in the Tender Document.
9. EMD to the tune of Rs. 18,973/- (Eighteen Thousand Nine Hundred Seventy Three only) in the form of DD issued from a nationalized bank in favour of Director cum Principal Atal Bihari Vajpayee Govt.
